## General Data Protection Regulations (GDPR)



### **Privacy Notice for Pupils and their Families**

Schools are required to inform pupils and their families about how their personal data may be collected and used. We comply with this right by providing 'privacy notices' (sometimes called 'fair processing notices') to individuals where we are processing their personal data.

This privacy notice explains how we collect, store and use personal data about pupils and their families.

#### Who processes your information?

We, Liscard Primary School, Withens Lane, Liscard, CH45 7NQ, are the 'data controller' for the purposes of data protection law.

#### Why do we collect and use your information?

Liscard Primary School holds the legal right to collect and use personal data relating to pupils and their families, and we may also receive information regarding them from their previous school, LA and/or the DfE. We collect and use personal data in order to meet legal requirements and legitimate interests set out in the GDPR and UK law, including those in relation to the following:

- Article 6 and Article 9 of the GDPR
- Education Act 1996
- Section 3 of The Education (Information About Individual Pupils) (England) Regulations 2013

In accordance with the above, the personal data of pupils and their families is collected and used for the following reasons:

- Support pupil learning
- Monitor and report on pupil progress
- Provide appropriate pastoral care
- Protect pupil welfare
- Administer admissions waiting lists (Early Years; 2-3 year olds)
- · Assess the quality of our services, for example
- To contact families for participation in surveys about our school and the services we offer
- For marketing purposes, only from Liscard Primary School / Friends of Liscard Primary School / Liscard Primary School / Friends of Liscard Primary School / Liscard Primary School / Friends of Liscard Primary School / Li
- · Comply with the law regarding data sharing

#### Which data is collected?

Personal data that we may collect, use, store and share (when appropriate) about pupils includes, but is not restricted to:

- Contact details, contact preferences, emergency contacts, date of birth, identification documents
- Parent/Carer contact details including their dates of birth and National Insurance Numbers
- · Results of internal assessments and externally set tests
- Pupil and curricular records

- Characteristics, such as gender, ethnic background, eligibility for free school meals, or special educational needs
- Behaviour and Exclusion information
- Details of any medical conditions, including physical and mental health
- Accident and Incident reports
- Attendance information
- Safeguarding information
- Details of any support received, including care packages, plans and support providers
- Photographs
- CCTV images captured in school

#### Collecting this information

We may also hold data about pupils that we have received from other organisations, including other schools, local authorities and the Department for Education.

Whilst the majority of the personal data you provide to the school is mandatory, some is provided on a voluntary basis. When collecting data, the school will inform you whether you are required to provide this data or if your consent is needed. Where consent is required, the school will provide you with specific and explicit information with regards to the reasons the data is being collected and how the data will be used.

#### How long is your data stored for?

We keep personal information about pupils while they are attending our school. We may also keep it beyond their attendance at our school if this is necessary in order to comply with our legal obligations. Our Retention and Destruction Policy sets out how long we keep information about pupils.

If you would like to obtain a copy of our Retention and Destruction Policy, please ask at reception or download it from our school website.

#### Will my information be shared?

The school is required to share pupils' data with the DfE on a statutory basis, this includes the following:

We do not share information about pupils with any third party without consent unless the law and our policies allow us to do so.

Where it is legally required, or necessary (and it complies with data protection law) we may share personal information about pupils with:

- Our local authority to meet our legal obligations to share certain information with it, such as safeguarding concerns and exclusions
- The Department for Education to meet our legal obligations to share certain information with it
- The pupil's family and representatives to meet our legal obligations to share certain information with them, such as medical or safeguarding concerns and exclusions
- Educators and examining bodies to meet our legal obligations to share certain information with them, such as special educational needs
- Our regulator, e.g. Ofsted to meet our legal obligations to share certain information with them
- Suppliers and service providers to enable them to provide the service we have contracted them for
- Financial organisations to enable them to provide the service we have contracted them for / to meet our legal obligations to share certain information with it
- Central and local government to meet our legal obligations to share certain information with it
- Our auditors to meet our legal obligations to share certain information with them
- Survey and research organisations to enable them to provide the service we have contracted them for
- Health authorities to meet our legal obligations to share certain information with it, such as medical or safeguarding concerns and exclusions
- Security organisations to enable them to provide the service we have contracted them for
- Health and social welfare organisations to meet our legal obligations to share certain information with it, such as health and safeguarding concerns and exclusions
- Professional advisers and consultants to meet our legal obligations to share certain information with it,

such as health, medical and safeguarding concerns and exclusions

- Charities and voluntary organisations to enable them to provide the service we have contracted them for
- Police forces, courts, tribunals to meet our legal obligations to share certain information with it, such as safeguarding concerns and exclusions
- Professional bodies, e.g. legal representatives, educational psychologists to meet our legal obligations to share certain information with them

#### **National Pupil Database**

We are required to provide information about pupils to the Department for Education (DfE) as part of statutory data collections such as the school census.

Some of this information is then stored in the <u>National Pupil Database</u> (NPD), which is owned and managed by the Department and provides evidence on school performance to inform research.

The database is held electronically so it can easily be turned into statistics. The information is securely collected from a range of sources including schools, local authorities and exam boards.

The Department for Education may share information from the NPD with other organisations which promote children's education or wellbeing in England. Such organisations must agree to strict terms and conditions about how they will use the data.

#### Transferring data internationally

Where we transfer personal data to a country or territory outside the European Economic Area, we will do so in accordance with data protection law.

#### What are your rights?

Individuals have a right to make a 'subject access request' to gain access to personal information that the school holds about them.

Parents/carers can make a request with respect to their child's data where the child is not considered mature enough to understand their rights over their own data (usually under the age of 12), or where the child has provided consent.

Parents/carers also have the right to make a subject access request with respect to any personal data the school holds about them.

Parents and pupils have the following rights in relation to the processing of their personal data. You have the right to:

- Be informed about how Liscard Primary School uses your personal data.
- Request access to the personal data that Liscard Primary School holds.
- Request that your personal data is amended if it is inaccurate or incomplete.
- Request that your personal data is erased where there is no compelling reason for its continued processing.
- Request that the processing of your data is restricted.
- Object to your personal data being processed.

Where the processing of your data is based on your consent, you have the right to withdraw this consent at any time.

If you make a subject access request, and if we do hold information about you or your child, we will:

- · Give you a description of it.
- Tell you why we are holding and processing it, and how long we will keep it for.

- Explain where we got it from, if not from you or your child.
- Tell you who it has been, or will be, shared with.
- Let you know whether any automated decision-making is being applied to the data, and any consequences
  of this.
- Give you a copy of the information in an intelligible form.

Individuals also have the right for their personal information to be transmitted electronically to another organisation in certain circumstances.

#### Other rights

Under data protection law, individuals have certain rights regarding how their personal data is used and kept safe, including the right to:

- Object to the use of personal data if it would cause, or is causing, damage or distress.
- Prevent it being used to send direct marketing.
- Object to decisions being taken by automated means (by a computer or machine, rather than by a person).
- In certain circumstances, have inaccurate personal data corrected, deleted or destroyed, or restrict processing.
- Claim compensation for damages caused by a breach of the data protection regulations.

To exercise any of these rights, please contact our data protection officer.

Parents/carers also have a legal right to access to their child's **educational record**. To request access, please contact Mrs Joanne Johnson, School Business Manager / Data Protection Officer.

#### **Complaints**

We take any complaints about our collection and use of personal information very seriously.

If you think that our collection or use of personal information is unfair, misleading or inappropriate, or have any other concern about our data processing, please raise this with us in the first instance.

## Privacy Notice Addendum Re: Collecting Medical Data during the Coronavirus (COVID-19) Pandemic

- 1.1 The law on protecting personally identifiable information, known as the General Data Protection Regulation (GDPR), allows Liscard Primary School to use the personal information collected from staff/parents/carers and pupils. This includes special category data such as medical data.
- 1.2 Due to this pandemic, we may need to ask for data that you have not previously supplied. This data will be collected for, and on behalf of Liscard Primary School to allow appropriate decisions to be made regarding assessing ability to return to school and ensure that appropriate measures are put in place to allow for this safe return.
- 1.3 Liscard Primary School, additionally may need to collect data about individuals that they reside with in order to factor in appropriate considerations for their wellbeing.
- 1.4 All data collected by Liscard Primary School will be processed in accordance with our retention, destruction, data protection and data security policies. For further information these can be found on the school's website.
- 1.5 The legal bases for using your data in these circumstances will be either (a) with your consent, (b) where it is necessary to process this data for the 'vital interests' of yourself or another person, (c) for the reasons of substantial public interest, (d) where it is necessary to assess the working capacity of an employee or (e) where is it in the interests of public health.
- 1.6 In the current pandemic, we may need to share select data with others. This can be with the NHS and emergency services, public authorities as well as other stakeholders. This will only be done where it is necessary and proportionate for us to do so.
